K. & O. Using Simulation to Introduce New Equipment

Attendees will analyze the limitations to current methods and the organizations involved with simulation equipment, in addition to categorizing the role of simulation in the educational process. Attendees will also create the overall goals of teachers, designers and administrators when introducing new devices to the educational format.

L. Interdisciplinary team behavior: Demonstration of Simulation Based Team

Behavior Instruction for Operating Room Crisis Management
The learner will be able to adapt into daily practice the three key competencies for effective team work in patient care. The key competencies include are Communication, Safety and Coordination.

M. Simulation: Feedback and Debriefing for Affective Learning

Attendees will apply the advocacy and inquiry approach to feedback to address observed behaviors in an open, collaborative way. Attendees will compare and contrast the various sources of learner anxiety, which can constrain both performances during a simulation and growth during the debriefing.

N. Integrating Simulation Into Curriculum

The attendees will learn how to devise simulation curriculum.

P. Milestones: Who, What, Where, When, Why?

To discuss and analyze the milestones and their development for anesthesiology thus far. Participants will organize and assemble goals for the Task Force to complete. Overall, attendees will plan an outstanding milestone product for anesthesiology.

Q. Leading with Emotional Intelligence

Attendees will examine and integrate leadership skills with emotional intelligence into their educational program. Attendees will experiment with relationship skills to navigate academics.

R. Designing Curricula for Improving Anesthesiology Resident Teaching Skills

Attendees will systematically and effectively develop curriculum for improving anesthesiology resident teaching skills.

T. Targeted Teaching Using Blog Architecture

The attendee will learn about computer blogs in anesthesia and critical care and utilize blogs to provide education within their department. This form of targeted teaching will employ attendees to enhance teaching with new technology.

Meeting Room Name Origins

George Benson (March 22, 1943) is a Grammy Award-winning American musician, whose recording career began at the age of twenty-one as a jazz guitarist. He is also known as a pop, R&B, and scat singer. This one-time child prodigy topped the Billboard 200 in 1976 with the triple-platinum album, *Breezin'*. Benson uses a rest-stroke picking technique very similar to that of gypsy jazz players such as Django Reinhardt.

Mary Stevenson Cassatt (May 22, 1844 – June 14, 1926) was an American painter and printmaker. Cassatt often created images of the social and private lives of women, with particular emphasis on the intimate bonds between mothers and children. She lived much of life in France, where she befriended Edgar Degas and exhibited among the Impressionists. The two worked side-by-side for awhile, and her draftsmanship gained considerable strength under his tutelage. He depicted her in a series of etchings recording their trips to the Louvre.

Henry Mancini (April 16, 1924 – June 14, 1994) was an American composer, conductor and arranger, best remembered for his film and television scores. He won a record number of Grammy awards, including a Grammy Lifetime Achievement Award in 1995. His best-known works are the "The Pink Panther" theme song, the "Peter Gunn" theme song and "Moon River".

James "Jimmy" Stewart (May 20, 1908 – July 2, 1997) was an American film and stage actor, best known for his self-effacing persona. Over the course of his career, he starred in many films widely considered classics such as *Mr. Smith Goes to Washington*, *The Philadelphia Story*, *Harvey*, *It's a Wonderful Life*, *Rear Window*, *Rope*, *The Man Who Knew Too Much*, and *Vertigo*. He was nominated for five Academy Awards, winning one, and receiving one Lifetime Achievement award. He also had a noted military career, a WWII and Vietnam War veteran, who rose to the rank of Brigadier General in the United States Air Force Reserve.

August Wilson (April 27, 1945 – October 2, 2005) was an American playwright. His literary legacy is the ten play series, *The Pittsburgh Cycle*, for which he received two Pulitzer Prizes for Drama. Each is set in a different decade, depicting the comic and tragic aspects of the African-American experience in the twentieth century. In Pittsburgh, there is an August Wilson Center for African American Culture. On October 16, 2005, the Virginia Theatre in New York City's Broadway theatre district was renamed the August Wilson Theatre. It is the first Broadway theatre to bear the name of an African-American.

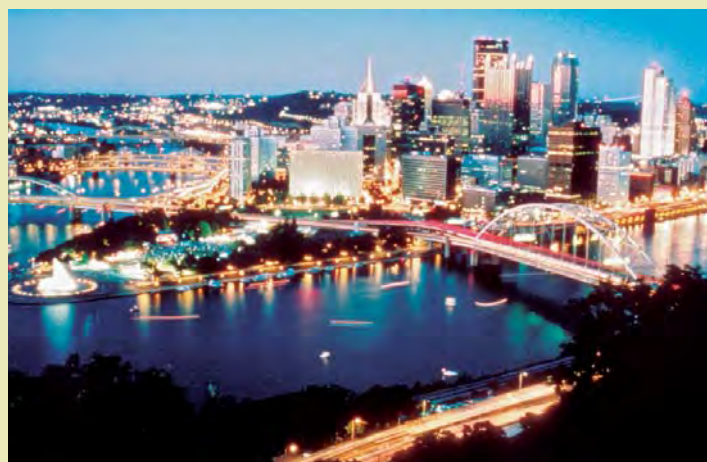

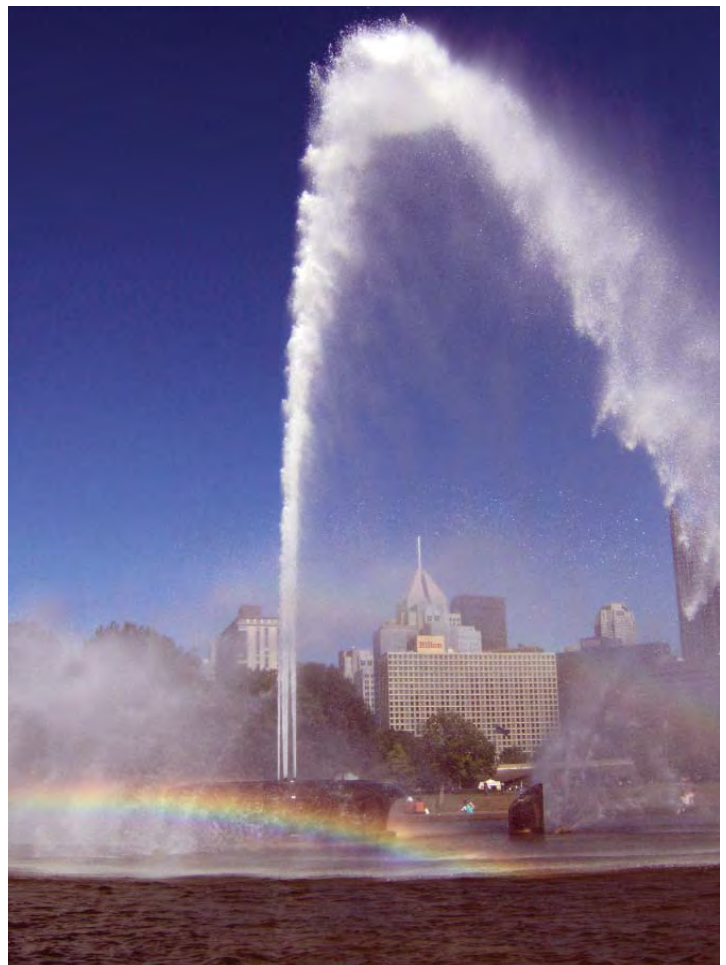
